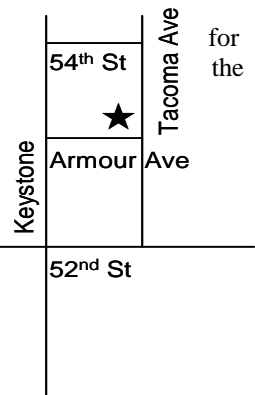

Four To The Fore

Success. A term bandied about almost every day in every type of aggregation in American culture. Its overuse comes with an assumed definition and hallowed subtext of understanding that is rarely ever analyzed. Upon that uncommon moment where the word success is indeed analyzed, the usual mode of discourse rarely deviates from a few assumed foundational givens: "Are we winning?" "Are we better than others? (a subset of winning)" "Is there a way to make money in our common purpose, and if so are we making all we can?" "Is our decision making data driven?" "Is everyone contributing and giving 110 percent?" "Are my needs being met?" "Am I receiving value with my participation?"



Granted, not every question above applies to every discussion of the word success. The queries listed are also not an attempt to be a comprehensive list. Those foundational "givens" are my attempt to get to the heart of a problem that is systemic in our current American milieu. To be shamelessly overt: BUSINESS is the hallowed model and paradigm which recklessly infiltrates and infects every attempt at defining and codifying success (and failure) in our culture.

Don't hate me yet. I love America AND I believe in good business practices, *for a business*. My wife and I are co-owners of an LLC. I'm even going to strive toward a second Master's Degree in Business and Marketing Education. I am not disparaging responsible capitalism, nor am I on the bandwagon of saying America is bad.

Here is my point: Success and failure have a myriad of ways to be measured and understood....yes even emotionally felt. The business paradigm of bestowing success and failure upon something DOES NOT WORK for everything. Here are a few examples:

A school is NOT, ontologically, first and foremost a business.
A (church/temple/etc.) is NOT, ontologically, first and foremost, a business.
A social club is NOT, ontologically, first and foremost a business.

A business is a business. Period. My family, for example, is not a business. I don't need metrics or data to KNOW that I love my children. I don't need a committee meeting to KNOW that I would die protecting them from harm. There is more than one way of knowing.

To be sure, there are business ASPECTS which are "necessary evils" in things like schools, churches, and social clubs. However, these assemblages of people do not exist, first and foremost, to obsess over the bottom line and data. They exist for fundamentally different reasons.

Any organization (or informal group of people with a commonality) would do themselves a valuable service by examining their purpose for existing. If their purpose falls within a business paradigm of existence...then indeed please use the business model of success as a worthy model of success or failure. (Here comes my fist gently pounding the lectern....) If their purpose, however, lands within some other paradigm of finding meaning, helping others, or simply feeling good about being together....then they would do well to find a way of knowing and being that fits uniquely who they are and how they determine success or failure.

(This article is NOT a criticism of Mensa. If you feel there are points which apply to Mensa, that is your own personal intuition...which you are entitled to. I have been dealing with these thoughts long before I was in Mensa.)

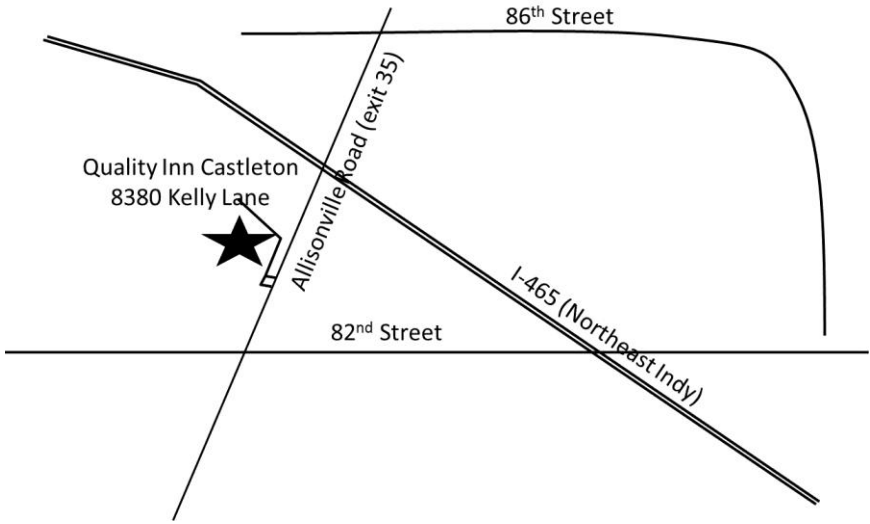
