## Sidebars from Lonely Planet: Night Court

Lonely Planet's 2000 edition of their guide book to New York City piqued people's interest in a hitherto lightly-visited city attraction, and according to information online, that interest has increased. In 2001, when my daughter Michelle and I visited New York, the attraction hadn't yet garnered the attention it has today. Here is a quote from the sidebar:
"If you find the 'Disneyfied' streets of New York disappointingly clean and safe, why not take an offbeat look at the city's dark underside by
 a few hours in Night Court? It's already popular with some more adventurous tourists."

It goes on to explain that by state law, anyone arrested in New York must be formally charged with the crime within 24 hours of the arrest, necessitating a night shift at the Criminal Courts Building near Chinatown.
"The evening shift runs from 5:30 p.m. to 1 a.m., with a parade of sad cases passing before a judge in two courtrooms in the fortress-like building. The accused plead guilty or not guilty and usually are set free on bail until the trial begins."

How could I pass that up?
We went to the forbidding structure late at night, well after the presumably boring early-evening miscreants had been sent on their way. Despite the book's assurance that all pretrial hearings must be open to the public, I couldn't escape the feeling that we weren't supposed to be there. I kept expecting someone to ask what our business was, and to kick us out when they discovered it was idle curiosity. Nothing of particular interest or import happened, and it certainly wasn't as much fun as the TV show Night Court had been. There weren't any microphones for our convenience, so it was difficult to hear what was going on, and it wasn't long before Michelle wanted to leave. She was in law school and probably figured she would eventually see enough of this kind of entertainment.
[This is a good place to explain that I can't get my kids to do some of the things I want to do when we travel. Four years after the Elian Gonzalez drama Michelle and I went to Miami on vacation. From Lonely Planet I learned that his great uncle had turned Elian's former bedroom into a shrine to the boy who captured our hearts. For a modest sum you could see his small bed and his Spiderman pajamas. We drove past the house in Little Havana and saw the yard Continued on next page
where Elian had been in the news, riding his pedal car, but I couldn't get Michelle to go in. Can you believe it? We were right there, but she drove on by. When Rhianna grew up she could have told people about visiting this attraction when she was almost two, but no. Opportunity squandered.

A few months later in San Francisco, neither my daughter nor my son would attend services with me at Anton LaVey's Church of Satan. (I was secretly relieved. And I certainly wasn't going alone.) It amused me to see the way the church's Yellow Pages ad (in an actual hard-copy phone book) was illustrated. There was a cartoon wizard, a moon and stars, and another image I've forgotten, all straight out of a clipart book. Wouldn't you think The Church of Satan could afford to hire an artist to draw something with horns and cloven feet? I mean seriously - a wizard?]

According to online magazine articles posted in the past couple of years, even as more tourists read the Lonely Planet guide book and visit Night Court, the onceraucous court becomes tamer as crime goes down and criminals become less interesting. I would go back to Night Court again, but next time I'd sit closer to the front.

## Voting Is a Privilege and a Responsibility

If you read your Bulletin regularly, you will have seen pages devoted to bylaw changes and amendments. While they appear quite lengthy, they are very important items which must be approved by you, as a member of Mensa.

Also in a recent Bulletin, the candidates for National Office positions are included with their biographies.


For those of you in Region Four, there are a number of great candidates who would like to represent you. Read the question and answer section and make your decision, but please don't neglect this very important process. Your vote counts and each candidate deserves your consideration of his or her background and reasons for running for the Regional Vice Chair position.

These people are all volunteers, so please keep that in mind. Mensa is truly a volunteer organization and those who seek an office are doing it for altruistic reasons. They care about Mensa and want it to be the best experience for our members.

If you read all of the bylaw amendments, then kudos to you for investigating and caring about the reasons behind the changes.

As an example, do you have an opinion regarding the number of Board Directors who attend meetings and vote? Then pay special attention to Article III, section (2) subsection (b) that removes the two most recent chairmen as elective officers.
Are you unhappy with the methods of the nominating committee and wish to change the process? Do you feel the candidates should have more than 250 signatures - or 100 for Regional Vice Chairs? Do you think audio recordings of the meetings should be allowed?

There has been a lot of discussion about the Ombudsman's role at the national level. Do you want this position to be more or less involved in the board's discussion? Check out Article VIII, section 1 and vote on the proposed changes.

If you don't feel strongly about any of the amendments, at least vote for Amendment 1 , which is recommended by the American Mensa Committee and replaces the current by-laws with updated ones.
You will be able to vote on these electronically if you have a valid email address on file with American Mensa and you have not specifically requested a paper ballot.

Voting for the International officers is by a paper ballot only. You will find it in the April-May Bulletin. Please read the biographies and make your decision and send in the paper ballot. For some reason, those of us in the United States, the largest Mensa group, fall short of the percentage of votes in some of our sister countries. Are we that US-centric that we don't support our International officers?

Our own former AML Chair, Elissa Rudolph, is running for re-election as International Chair, and this time she has opponents. Elissa would very much appreciate your vote for her second term in this position.

I challenge you to send in those ballots and I am going to see if Region Four surpasses the other regions in choosing our International officers. Your American Mensa Board has approved some of the candidates, but you should consider all of those running to make your own determination.

Voting is a privilege, but it is also a responsibility. If you decide not to vote, then don't complain, especially about the outcome of the bylaw amendments. It's your choice. Take advantage of that and help guide American Mensa into the future.

## 2015 Mensa National Elections - A Closer Look by Shayna Mali, French Broad Mensa

In the 2015 Mensa national elections next April, there will be no fewer than thirteen (13) different bylaws amendments for members to evaluate and vote on. There will also be multiple candidates for several of the national offices. This level of interest and participation on the national level has not been seen for quite some time - and it has gotten my attention. Having done a fair amount of research and then reviewed all 13 of the proposed bylaws amendments, I find myself unable to support anything substantive put forward by the current American Mensa Committee (AMC). Nor will I be supporting any of the incumbents on the AMC ExComm. Discussions continue on Facebook, yahoo groups and the Mensa Online Community, as well as in person across the country. I invite you to join the conversation.

A significant issue is the pattern of continuing dues increases, outpacing the inflation rate. The current AMC has approved these dues hikes but, until now,
they have resisted repeated attempts by the current Treasurer, Nick Sanford now running for Chairman - to institute automatic annual dues increases. We will have other choices for both Treasurer and Chairman this year; it behooves us to consider how our dues money is spent and whether we are getting additional value for higher annual dues. Several members have pointed to the ongoing expansion of the National Office without an accompanying growth in membership numbers. Others have called for a different approach to the budget process and an accompanying rollback of dues; to achieve this, we would need quite a different AMC and ExComm.

A careful reading of the proposed bylaws amendments, along with a review of this year's AMC meetings agendas and minutes, reveals quite a lot about the thinking of the incumbents who participated in the creation of AMC-approved amendments and who would be operating under the revised rules if those amendments were to pass. A recent RVC column by Julia Ashley (Region 3) and the subsequent response from Dayton Area Mensa's Ombudsman Pat Reising elucidate some of the issues relative to the position and role of the National Ombudsman. The links below lead to an exchange regarding two of the proposed bylaws amendments: \#1, Replacement of the text of Bylaws of American Mensa in entirety, and \#12, Restore and Protect Powers of the National Ombudsman. An associated proposal, \#11, Duties and Responsibilities of the National Ombudsman, is referred to indirectly in the writings and should be considered as part of the same discussion. Among these three amendments, I support \#12 and plan to vote against \#1 and \#11.

## AML Election Issues: By-Laws

During the upcoming American Mensa Ltd. (AML) elections some 13 amendments are being offered to the By-laws. For your information and convenience they were printed in a 24 page insert in the middle of the January Bulletin, so everyone had a chance to look at them.

Amendment 1, submitted by the American Mensa Committee (AMC), proposes a complete rewrite of the by-laws. The ExComm and AMC are writing the road map for the future of AML. As they considered the new by-laws, they probably thought the electorate would not be reading the lengthy text and considering all the
 implications. As AML voting history shows, incumbents usually gain re-election (either in their current positions or in the next one they run for), in part due to Mensa voter apathy, so these by-laws submitted by the AMC are tailored to give the current ExComm the structure they desire to steer the course they have embarked upon over the past period(s).

However, an awakened electorate, which studies the by-laws, considers the changes from past practice and the future of the organization under them, will approve or reject them based on how the ordinary Mensan (an oxymoron - all Mensans are, by definition, extraordinary) wishes to experience her or his club.

I have gone through the by-laws quickly and I am not likely to agree to Amendment \#1. I think an Ombudsman, to be effective, needs to have access to all information in a case, and not just what some folks want to give him or her. This would be a reason for me to vote for Amendment \# 12. Furthermore, I am bothered that the American Mensa Committee as a body would be eliminated and replaced by a "Board" as if Mensa were any garden variety corporation. I think the Amendments \#2 and \#3 taking voting rights from AMC members who were not elected, but rather appointed, or who had once been elected, but now are merely emeritus members an excellent idea and supported by my sense of direct democracy. Indeed, I see no reason whatsoever to have a past and a past past Chair still on the AMC. If current AMC members want their advice, they can contact them directly on an issue - practically everyone has a cellphone (with loudspeaker capabilities) these days. I very much like Amendment 10 which would open meetings to the entire membership, rather than just those who happen to be physically present, via Audio and Video recordings. I am not sure how I will vote on the Amendment \#5 to eliminate the Nominating Committee altogether, although I have heard people who have served on it in the past speak in favor of its elimination. As you can see, I have only skimmed the surface of the proposed Amendments, more work needs to be done by the voting public.

It would be advantageous if all candidates - current ExComm and AMC members as well as the numerous challengers - would declare their opinions on the proposed sweeping by-law changes. ${ }^{1}$ Do the changes increase or decrease
democracy in the organization? Do they streamline cumbersome practices or do they eliminate valuable checks on ExComm or National Office power?

As the activities of AML move away from volunteer run to the paid employee at the national office, voters should be asking themselves, is our organisation a business like any other or (still) what the membership makes of it.
